## LIMITED WARRANTY COVERAGE

---

### **THIS WARRANTY WILL ONLY BE HONOURED IN THE GEOGRAPHICAL LOCATION IN WHICH THE PRODUCT WAS PURCHASED.**

Trimcraft LTD will replace or repair the Computerised Sewing Machine should it fail to function properly during the warranty period, subject to any conditions and/or limitations stated herein.

Such repair service will include all labour as well as any necessary adjustments and/or replacement parts.

Such repair or replacement is the sole remedy under this warranty. Replacement parts are used in making repairs; these parts may be re-manufactured, or may contain re-manufactured materials.

If it is necessary to replace the entire product, it may be replaced with a re-manufactured product.
